In the year of program prioritization at the University of Saskatchewan – known as Transform US - STM continues to offer distinctive academic programs that showcase the strengths of our faculty and the priorities of the college.

Our interdisciplinary Minors - Catholic Studies, Social Justice and the Common Good, Ukrainian Studies, and Jewish and Christian Origins – will not be directly affected by the University's cuts, as STM provides the resources for these programs. We were delighted to see the first graduates of these new programs at Spring Convocation. This year we continue our first-year Learning Community offering introductory Philosophy and Political Studies to a single cohort, while also adding classes in Archaeology and Indigenous Philosophy to the Aboriginal Student Achievement Program in Arts and Science. Although we teach courses and programs not offered by the U of S, all of our courses are open to all U of S students regardless of their college affiliation.

With the new addition to our building nearing completion, we look forward to offering more classes at STM. Students and faculty are enthusiastically anticipating Term 2 and the first classes in these new, state-of-the-art classrooms. We are also thinking of expanding our spring and summer offerings on campus to make better use of our expanded facility and increase academic options for students. There are exciting opportunities for study abroad, too – from Spring Session in Ukraine to international service learning placements in Honduras and Ecuador.

Margaret Dutli Award

The Margaret Dutli award is to acknowledge a sustained involvement in community service by STM faculty, as well as express a public commitment to the mission of STM. The 2013 Margaret Dutli Professional and Community Service Award was presented to STM's Professor Wilfrid Denis PhD, MA, BA.

Professor Denis has been a member of STM's faculty since 1979. His ongoing activism to sustain and promote the flourishing of Fransaskois culture and language rights – provincially, nationally and internationally – now spans over three decades. He has served the community as an advocate, spokesperson and policy-maker in a variety of ways.

Dr. Denis has displayed thirty-plus years of servant-leadership cultivating the art of scholarly praxis: his passion for his heritage drove him to acquire theoretical expertise in issues related to francophone communities in minority settings, and this in turn equipped him to play a practical role in publicly advocating for Fransaskois values and goals. At the same time, such intense, engaged interaction with the Fransaskois community has dialectically fed, shaped and reshaped his sociological scholarship and teaching.

Such devotion to honouring diversity while creating community, to fostering understanding and a vital sense of interdependence among local and increasingly global 'neighbours,' concretises another mode of praxis as well: the Catholic application of intelligence and faith which enables more and more people to come to the full measure of their humanity. (Ex corde ecclesiae). All these qualities and commitments make Professor Denis an invaluable contributor to the college's mission and a model recipient of the Margaret Dutli Professional and Community Service Award. **Congratulations Wilfrid.**

RESEARCH RESULTS ON PERSON-CENTRED DEMENTIA CARE

*Do beliefs about personhood
in dementia influence health
providers' approaches to
patient care?*

Interest in person-centred dementia care has flourished in the last two decades. As a clinical Psychologist, and Assistant Professor in Psychology at STM, Paulette Hunter became involved with this research between 2008 and 2010. The goal was to help health providers learn valuable person-centred dementia care strategies for on the job and to help understand whether beliefs about personhood in dementia influence health providers' approaches to patient care.

'Personhood' refers to an individual's rights, abilities, status, dignity and respect. 300 participants – nurses and continuing care assistants – read a series of fictional case studies about patients who were displaying signs of pain and agitation, and decided which type of follow-up care they wished to recommend. Some of the patients described in the case studies had dementia and others did not. Response options included pain medication, anxiety medication, and non-pharmacological alternatives. The caregivers also filled out a set of questionnaires about beliefs about personhood, burnout, and job satisfaction.

The report findings confirmed that person-centered care is important especially in dementia care. There tends to be a bias to assume psychological problems versus medical, as dementia patients often cannot express their physical issues.

Results also suggested that patients with dementia are generally not receiving adequate pain management, and may instead be receiving too many anti-anxiety medications. However, if their caregiver or attending health professionals are sensitive to the individual's 'personhood' the course of treatment may be assessed differently. Caregivers with stronger person-centered beliefs along with more knowledge of best practices in dementia care will tend to investigate more closely to determine the core of the problem when there is some doubt. Other results of this study revealed a sense of personal accomplishment was associated with positive beliefs about personhood in dementia.

Funding for this research was provided by a Canadian Institutes of Health Research Doctoral Research Award to Dr. Hunter. Appreciation is noted for the participation of several long-term care facilities in the Regina Qu'Appelle Health Region.

25th Michael Keenan Memorial Lecture

The Keenan Lecture is an annual public lecture by a distinguished visitor on topics reflecting the range of disciplines at St. Thomas More College. The lecture was established to honour well-respected Michael Keenan, who served as STM's first Dean from 1974 to 1984.

An award-winning author, playwright and recent recipient of the province's highest award in the arts, the Lieutenant Governor's Award for Lifetime Achievement in the Arts, Guy Vanderhaeghe was an ideal choice for the 25th Michael Keenan Memorial Lecture held on October 24th. Guy spoke to a full house with his chosen topic '*Apprehending the Past: History versus the Historical Novel*' where he discussed on what terms we judge a historical novel when it combines both fiction and history.

A Saskatchewan native, Vanderhaeghe received his BA and a MA in History from the University of Saskatchewan, and a BEd from the University of Regina. He is our Scholar (a position created to recognize distinguished scholars with a national or international reputation who are actively associated with STM) and teaches a much sought after creative writing course at the College.

Paper Currency Exhibit at Ukrainian Museum of Canada

Curated by Professor Bohdan Kordan, an exhibit was organized by the Prairie Centre for the Study of Ukrainian Heritage, at STM, in co-operation with the Ukrainian Museum of Canada and the Oseredok Museum and Art Gallery of Winnipeg. The exhibit will run from September 10, 2013 through to December 31, 2013 at the Ukrainian Museum of Canada (Saskatoon) and is scheduled to travel to other venues across Canada.

In the wake of the Great War, from the detritus of imperial collapse there emerged a new political order of nation-states. Amongst the newly established entities there appeared an independent, sovereign Ukraine. From the outset, Ukraine was the object of invasion and its survival was in doubt. Nevertheless, in the search for legitimacy, extraordinary efforts were made to affirm the state's sovereign, national character. This was to be accomplished by consciously connecting with Ukraine's historical past both to invoke precedence and encourage a narrative of political continuity. The symbols introduced in the currency of Ukraine during this revolutionary period were examples of this process.

The exhibit "Money, Sovereignty and Power: The Paper Currency of Revolutionary Ukraine" documents this process, describing the use of symbols in the currency produced by various successive governments during the period of the Ukrainian Revolution.

The Les and Irene Dubé Community Service-Learning Program (CSL) at St. Thomas More College (STM) offers students a unique opportunity to deepen their academic education while serving real community needs. One of the ways STM students can access an immersive service-learning experience is through the Intercordia program.

In partnership with Intercordia Canada, St. Thomas More College provides up to 14 students with an 8-week international community service-learning experience. Students gain credit in Sociology classes while living with and learning from people throughout the world.

While pursuing her Political Studies degree at the U of S, Alanna Carlson became involved with STM College first through the Just Youth program then enrolled in STM classes. "I quickly realized classes at STM were great," said Carlson, "The professors were engaged with the subjects and helped me care about what I was learning." Soon she was involved with STMSU, Campus Ministry, the Intercordia Canada program while completing a Minor in Critical Perspectives on Social Justice and Common Good.

Ms. Carlson participated in Intercordia's project in Honduras in 2013, where she worked in an elementary school teaching English. "Every day was a learning experience," said Alanna. "I quickly understood the value of relationships in a community." The 8 weeks brought new insight related to health challenges, spirituality, and cultural and political relationships within the small Central American community.

Alanna Carlson, BA 2013 was awarded the STM Newman Alumni Association Award this spring, presented to a graduating student who has demonstrated a commitment to Christian service and/or portrays all around excellence in leadership both on and off campus. Alanna is attending the college of Law at the U of S, maintaining involvement in socially just initiatives with Just Rights and Canadian Lawyers Abroad.

STM Campus Ministry hosts successful Student Conference

October 18-20, St. Thomas More College played host to students and campus ministers from Toronto all the way to Victoria, for the Western Regional conference of the Canadian Catholic Students Association (CCSA). The conference began Friday, October 18th with a talk by Fr. Matthew Ramsay, and also included a Taize prayer service.

Other conference highlights included an ecumenical prayer, a talk on Poetry, Creativity and Call by Bishop Don Bolen and a student panel that explored service opportunities in Saskatoon, as well as in the Maritimes, and in the global south.

Conference presenters included Mr. Mel Zimmer, recently retired Science teacher from the Greater Saskatoon Catholic schools, and Dr. Alisha Pomazon, professor of Judaic studies at St. Thomas More. The two speakers took turns looking at our stories of creation from both a religious and scientific perspective. The weekend was rounded out by a Divine Liturgy presided by Fr. Andre Lalach, and a Creativity Coffeehouse, which was sponsored by the Newman Centre, one of the oldest campus clubs at the U. of S., founded in 1926.

The conference culminated Sunday October 20th with a CCSA AGM, and a chance to reflect on the weekend. There was definitely an excitement around the gathering, and participants were left looking forward to next fall's national gathering for the CCSA which will be held at St. Joseph's College in Edmonton.

CONSTRUCTION UPDATE

There is great anticipation throughout the College to begin 2014 incorporating the new classroom, study, research and office space into the STM experience, promising great benefits:

- Approximately 325 new student seats in classrooms. Incorporation of new technology in classrooms with opportunity for distance learning.
- 1,000 square feet of dedicated student study space and group breakout rooms.
- 4 new research labs for social scientists. Increased office space bringing the average number of sessional lecturers per office down from 3.2 to 1.67.
- Increased social and meeting space for students, faculty and staff of 2,000 square feet in the year-round accessible natural light atrium.
- Energy savings of \$75,000 per year by installing dedicated boilers in STM. Energy savings of \$25,000 per year by installing LED lights and related control mechanisms.

St. Thomas More Medal

The St. Thomas More Medal was established to recognize and honour persons, groups of persons, and organizations which have combined personal qualities of care, integrity and faith with significant contributions to community and public life.

The award is named after Thomas More whose extraordinary example of faithful virtue and public service remains an inspiration 'for all seasons.'

The 2013 recipient of the St. Thomas More medal is *Sister Callista Arnold*.



Born in Prelate, Saskatchewan, Sister Callista Arnold was one of 10 children born to Romanian immigrant parents. Family has always remained a vital part of her life. Although Sister Callista grew up poor, her parents always instilled in their children deep faith, trust and belief in prayer. She has always had a great appreciation of nature – water and the skies; with these elements often serving as motivation for her paintings as a gifted artist. After attending a one-room country school until Grade ten, Sister Callista went to St. Angela's Convent in Prelate. She entered the Ursulines at 17, making her final profession at the age of 21.

Sister Callista acquired her teaching certificate in 1954, spent 25 years in the teaching profession, came to the U of S to enrich her teaching and then pursued a Theology degree in Ottawa in 1971. In 1988, Sister Callista stepped into the Pastoral Associate position at St. Anne's parish in Saskatoon. By 1995 she felt a calling to become involved as a compassionate presence with Persons Living With AIDS (PLWA). PLWA is a volunteer, non-profit organization whose aim is to build a network providing support and social activities for persons diagnosed with HIV disease. Her role would include visiting people in their homes, in hospitals and within palliative care homes.

Sister Callista has stated that this ministry is "walking with people made in the image and likeness of God." She has worked, laughed and cried alongside the people of our city who live with being HIV infected or who have full-blown AIDS. She reflects that attending to those dying of AIDS can be very difficult because of the physical, emotional, psychological pain and spiritual struggle of these people.

As is very evident in this brief recount of Sister Callista's faith and public service, we see she is a wonderful example of the qualities we seek for the STM Medal recipient.

She has been quoted as saying her hope is that "all Christians will be gifted with faith that is deeply rooted in the Gospel – a Gospel of hope, acceptance and commitment." Ultimately Sister Callista hopes to provide people strength for life's journey.

We know that accomplishment to be true.

Distinguished Alumnus 2013

Professor Emeritus William Earle DeCoteau (BA1960) Doctor of Medicine 1964

Dr. Earle DeCoteau was very involved with STM college as a student and became active with STM's Newman Club as well. After receiving his BA in 1960, he became a medical student completing the four year medical school program with the U of S College of Medicine in 1964.



Dr. DeCoteau returned to the University of Saskatchewan as a faculty member in the Department of Medicine in 1972 and by 1980 became a full professor. He was head of the Immunology and Rheumatology program from 1974 to 1988. In 1988 he took a study leave to pursue the field of Geriatrics at McMaster University. From 1989 to 2004 he was head of the section for Geriatrics in the College of Medicine.

Dr. DeCoteau has remained active in the Geriatric Program at City Hospital and also runs a dementia clinic at Providence Place in Moose Jaw where he serves as Medical Director. A strong advocate for the many sufferers of dementia, he is still active in research, focusing on the often under-diagnosed vascular disease of the brain.

Reflecting his concern and commitment to the future, as President of the College of Medicine Alumni Association, Earle DeCoteau was involved with the establishment of the Medical Student Bursary program, while here at STM, Dr. DeCoteau established a student bursary in memory of his late wife Anne Phelan Decoteau.

Dr. DeCoteau has four children, 3 of whom are STM Alumni. His daughter Mary Jo DeCoteau was the recipient of the STM Distinguished Alumnae award in 2009.

A strong supporter of the College over the years, Thomas Molloy is proud of the four generations in his family who have also been part of the St. Thomas More legacy. From his aunt Mary Molloy, an STM student having graduated in 1940, his brother George and sister Mary, his four daughters, Cori, Jennifer, Alison and Kathryn, to Tom's granddaughter Hanna Howe who currently is building on her education through offerings at St Thomas More College.

Dr. Molloy has fond memories of the College from his days on campus in the late fifties. A graduate of St. Paul's high school in Saskatoon, also served by many Basillian teachers, it seemed a natural progression to attend STM, where he was already familiar with many of the faculty. Involved with student council at St. Thomas More College, Molloy recalls a great camaraderie within the College, "Many Catholic students from other colleges across campus would join STM's Newman Club, and hang out because of the inviting facilities. STM was original source of many of my friendships to this day."

A member of STM's Board of Governors for the past 6 years, Thomas Molloy provides great depth in support, reason and advice. Starting out as a student at STM he received a BA from the U of S, then went on to graduate from the U of S College of Law in 1964. He is well recognized for his role as chief negotiator for the Government of Canada in the Nunavut Land Claim Agreement. In 1996 he was named an Officer of the Order of Canada and 2001-2007 he was Chancellor for the University of Saskatchewan. Today he is respected nationally as a talented negotiator and strategic advisor having formed his own negotiation firm.

We thank both Thomas and the Molloy family for their role in building the history that is St. Thomas More College.

Now, working as a litigator with MacPherson, Leslie Tyerman (MLT) in Saskatoon, Ashley focuses on assisting clients with their legal challenges.

Ms. Smith is also a sessional lecturer at the College of Law and recently published her first book, *Victim Impact Statements: Past, Present and a Look to the Future*. Teaching the Western Canada Moot Team at the College of Law, she is going into her 5th year as coach and celebrates a remarkable record of success. In the last four years, they have placed in the top two teams in the Western Canadian leg of the competition (taking the title twice) and have won the national competition twice (the first team in the competition's history to win two years in a row). In 2010, Ashley Smith was the recipient of the 2010 YWCA's Woman of Distinction Award in the Youth Category. Ashley remains an avid performer and continues in musical theatre with the Saskatoon Summer Players.

Ms. Smith has maintained her involvement with STM by serving on Corporation since 2009 and being a Director of the STM Lawyers' Guild since 2009.

The Red Mass, introduced in England in the reign of Edward I in 1310, traditionally was celebrated to invoke inspiration of the Holy Spirit on behalf of those involved in the administration of justice. It takes its familiar name from the colors of the different judicial robes and that of vestments worn by the presider of the liturgy.
